CLUB PROCESSING

- Screening of the Application- strictly with complete documentary requirements
- Interview- to be scheduled after submission of complete documents and confirmation from the Proposer and Secunder
- Final Approval- 2-3 weeks after interview
- Activation of Account
- Issuance of Temporary Card – for request upon activation
- Issuance of Permanent Card - 2 to 3 weeks after final approval
- Issuance of Stock Certificate - 3 to 6 months after final approval
